It's the Holidays, Now What?

EVERY YEAR AROUND THIS TIME I SEE MY CLIENTS STRESSED OUT AND SAD because the holidays are around the corner. It's Halloween (costumes and trick or treating) then Thanksgiving (with how to plan double dinners) and finally Christmas and Hanukkah (with gift giving). What used to be a joyous time of year has turned into, "I just can't wait to get through it" time of year.
